COMPLAINT CASE NO. 8 OF 2021

- 1. Perused the administrative note dated 31.08.2021 indicating that a complaint has been filed by one Soibam Ibosing Meitei. We have perused the Complaint and on such perusal it is clear that the Complaint bears a court fees stamp of Rs. 5 and the Complainant has deposited a sum of Rs. 1000/- by way of Demand Draft the complaint also fulfils all the requirement for filling a Complaint before Manipur Lokayukta as provided under Rule 15 of the Manipur Lokayukta Rule, 2018.
- 2. The Complaint states that Shri Gourogobind Girls' College, Khurai Sajor Thoidingjam Leikai, Imphal East is the absolute honour of Patta Land Jamabandi bearing No. 252(Old) 343/514 (New) measuring an area of .49 (point four nine) Acre situated at village No. 15, Khurai Sajor Thoidingjam Leikai, Imphal East. The complaint is alleging that the original area of the college which is .49(Point four nine) acre had been reduced by .18(point one eight) acre and thereby resulting the whole area of the Shri Gourogobind Girls' College, from .49(point four nine) acre to only .31(point three one) acre. The Governing Body of the Shri Gourogobind Girls' College had inquired as to why the said area of the said Patta recorded in the name of Shri Gourogobind Girls' College had been reduce to .31(point three one) acre by approaching SDC, Porompat, Imphal East and the DC Imphal East by filling necessary application but inspite of repeated request made by the governing body, the learned SDC, Porompat had fail to give the reason as to why the said Patta land of the Shri Gourogobind Girls' College had been reduced from .49(point four nine) acre to only .31(point three one) acre. It is also alleged that the General Body of the said College had approach the DC Imphal East, requesting him for giving proper instruction to the SDC, Porompat for giving a reason and under what order the original Patta of Shri Gourogobind Girls' College had been reduced from .49(point four nine) acre to only .31(point three one) acre.
- 3. The allegation made in the complaint has been supported by documents annexed in the present complaint. After careful perusal of the compliant and the supporting documents, we are of the considered view that there is a prima facie case for conducting a

preliminary inquiry as to why the original area of the said Patta recorded in the name of Shri Gourogobind Girls' College had been reduced from .49(point four nine) acre to only .31(point three one) acre.

- 4. On careful perusal of the allegations and assertions made in the complaint and supporting documents, we are of the considered view that a prima facie case has been made out for directing the Director (Inquiry), Manipur Lokayukta to conduct a Preliminary Inquiry as to whether a prima facie case has been made out for investigation and for further proceeding. Accordingly, Director (Inquiry), Manipur Lokayukta is directed to conduct a Preliminary Inquiry to find out the fact and allegations and assertion mentioned specially in the additional fact(s) and supporting documents filed by the complainant, relevant portion of which has been already quoted above and submit a report within the period provided under Section 20 (1) of the Manipur Lokayukta Act, 2014 and Manipur Lokayukta Rules, 2018.
- 7. It is also made clear that the Director (Inquiry), Manipur Lokayukta and his team while conducting the Preliminary Inquiry shall keep in view their powers and jurisdiction as provided under Subsection (1), Sub-section (2), Sub-Section (4), Sub-section (5) and Sub-section (9) of Section 20; Section 21; Section 22; Section 26; Section 28 (2); Section 29; Section 32; Section 36 and other provisions of Manipur Lokayukta Act, 2014.
- 8. Deputy Registrar, Manipur Lokayukta is directed to furnish a copy of this order and other relevant documents to the Director (Inquiry), Manipur Lokayukta.
- 9. Await report from the Director (Inquiry), Manipur Lokayukta.
