1. Perused the office note dated 04.03.2022 of the Deputy Registrar, Manipur Lokayukta.

2. The Investigating Officer has submitted the Investigation Report as provided under Section 20 (6) of the Manipur Lokayukta Act, 2014 and a copy of the Investigation Report is also placed before Manipur Lokayukta. Further, Section 20 (7) of the Manipur Lokayukta Act, 2014 provides that Lokayukta shall consider every report received by it under sub-section (6) from the Investigating agency and after obtaining the comments of the competent authority and the public servant, may (a) grant sanction to its Prosecution Wing or investigating agency to file charge sheet or direct closure of report before the Special Court against the public servant and (b) direct the competent authority to initiate the departmental proceedings or any other appropriate action against the concerned public servants. For easy reference Section 20 (7) of the Manipur Lokayukta Act, 2014 is quoted hereunder :

(7) The Lokayukta shall consider every report received by it under sub-section (6) from the Investigating agency and after obtaining the comments of the competent authority and the public servant may—

- (a) grant sanction to its Prosecution Wing or investigating agency to file charge sheet or direct closure of report before the Special Court against the public servant;
- (b) direct the competent authority to initiate the departmental proceedings or any other appropriate action against the concerned public servants.

3. Section 20 (7) of the Manipur Lokayukta Act, 2014 mandates the obtaining of the comment from the competent authority and public servant(s) for considering as to whether prosecution sanction is to be granted or not to its Prosecution Wing or investigating agency to file charge sheet or direct closure of report before the Special Court against the public servant. The 'competent authority' and 'public servant' under the Manipur Lokayukta Act, 2014 are clearly defined under Section 2 (1) (c) and Section 2 (1) (m) of the Manipur Lokayukta Act, 2014 respectively. For easy reference Section 2 (1) (c) and Section 2 (1) (m) of the Manipur Lokayukta Act, 2014 are reproduced hereunder:

<u>S. 20 (1) (m)</u> :

"public servant" means a person referred to in clauses (a) to (g) of sub-section (1) of section 14 but does not include a public servant in respect of whom the jurisdiction is exercisable by any court or other authority under the Army Act, 1950, the Air Force Act, 1950, the Navy Act, 1957 and the Coast Guard Act, 1978 or the procedure is applicable to such public servant under those Acts;"

4. On perusal of the present Investigation Report, it is clear that investigation report has been submitted against the 7 (seven) accused persons namely,

5. As clearly mentioned, in compliance of the requirement mentioned under Section 20 (7) of the Manipur Lokayukta Act, 2014, the comment to the Investigation Report are to be obtained from the competent authority of the 5 (five) accused public servants and also from the 5 (five) accused public servants themselves, namely :

6. Deputy Registrar, Manipur Lokayukta is directed to call comment to the Investigation Report from the competent authority of the said 5 (five) accused public servants and also from them i.e. 5 (five) accused public servants themselves for taking a decision as provided under Section 20 (7) of the Manipur Lokayukta Act, 2014.

7. Deputy Registrar, Manipur Lokayukta is further directed to obtain the comment from the competent authority and the 5 (five) accused public servants to the investigation report on or before **23.03.2022**.
