Perused the administrative note dated 11.09.2020 wherein Deputy Registrar, Manipur Lokayukta noted that Director (Inquiry), Manipur Lokayukta has furnished a report from the office of Superintendent, Central Jail, Tihar, New Delhi that UTP, Shri Mutum Shyamo, S/o (L) M. Amutombi Singh of Lalambung Makhong Takhellambam Thangjam Leirak, Imphal West has expired on 18.06.2020.

On 24.08.2020, we have directed Director (Inquiry), Manipur Lokayukta to submit a report as to whether Dr. L. Shyamo Singh, then Director JNIMS Hospital expired on 18.06.2020. In compliance of that order dated 24.08.2020, Director (Inquiry) submitted has furnished a report from the office of Superintendent, Central Jail, Tihar, New Delhi that UTP, Shri Mutum Shyamo, S/o (L) M. Amutombi Singh of Lalambung Makhong Takhellambam Thangjam Leirak, Imphal West has expired on 18.06.2020. The Director (Inquiry) submitted the Preliminary Report wherein it is mentioned that Dr. M. Shyamo Singh, Ex-Director, JNIMS in collusion with others has purchased the HPLC machine at an escalated price. Thus, they have incurred a huge amount of Government's money while purchasing the said HPLC machine. In the above context, the Inquiry Wing, Manipur Lokayukta framed charges against the respondents i.e. Respondent No. 1 Dr. M. Shyamo Singh, Ex-Director, JNIMS, Porompat Respondent No.2.Dr. Angam, Professor Dept of Forensic Medicine JNIMS, porompat, Imphal East. Respondent No. 3. Dr. L. Fimate, the then Head of Department, Forensic Mwdicine JNIMS, Ebenezeer Villa. Laimanai, Langol, Imphal West District, Manipur.

It is provided under Section the PC Act, 1988 that are punishable
