

COMPLAINT CASE NO. 1 OF 2020

12.01.2021

[1] By an order of the Lokayukta dated 17.06.2020, Director (Inquiry), Manipur Lokayukta was directed to conduct a Preliminary Inquiry as to whether there exists a prima facie case for conducting investigation for the allegations made by the Complainant in the present complaint.
