1. Perused the letter of the Director Inquiry dated 12.01.2021 and also the letter of the investigating officers Shri S. Hemanta Singh, Addl SP/V&AC PS Manipur dated 12.01.2021 to the Manipur Lokayukta requesting for extension of the period for completion of Investigation of the present case FIR No. 8(9) 2020V&AC PS U/s 420/120B IPC and 13(2) r/w 13(1)(c) (d) of PC Act, 1988 for another six month w.e.f. 22.01.2021. In the said letter, the investigating officer stated that the progress of investigation of the present case had been hampered by the different orders of the Government of Manipur in restricting the movement of persons due to Covid-19 Pandemic. It is made known to the public by Government of Manipur that the movement of persons and activities are restricted. Since those orders are public orders we take judicial notice of the said orders. of the investigating officer to complete the investigation within the period mentioned in the Manipur Lokayukta Act, 2014. For the ends of justice and fair play, the period for completion of investigation is further extended for another period of six months w.e.f. 22.01.2021.
