COMPLAINT CASE NO. 2 OF 2019

- 1. We have perused the administrative note dated 15.03.2022 wherein it is stated that the Investigating Officer of Complaint Case No. 2 of 2019 under his letter dated 11.03.2022 has informed that there has been inadvertent error in listing the names of accused in the investigation report and it has been duly rectified i.e. the mistake in the listing of the name of the accused in the investigation report is as follows:
 - "1) K. Premkumar Singh (59) yrs, the then SE-III, PWD, Manipur, S/O(L) K. Gulap Singh, of Chingakham Leikai, Moirangkhom, near Brajalal Institute of Sciences, Imphal West, PS Imphal.
 - Oinam Inaoba Singh (61) yrs, the then EE, TPL Div. S/O (L)
 O. Mani of Khongman Zone-IV West, P.S Irilbung, Imphal East, the then EE.
 - 3) Shri Soiminthang Singson (60) yrs, EE, TPL Div. S/o late Nehkhopao Singson of Moreh Ward No. 9, Chikim Village, P.O. & P.S. Moreh, District Tengnoupal, District Tengnoupal a/p PWD Complex, Khuyathong, Imphal.
 - 4) Veineillam Haokip (39) yrs, AE, Sub-Div.II, Moreh, TPL Div. W/o Paojalal Haokip of Sugnum Munpi village, PO & PS Sugnu, Dist. Chandel a/p Qtr No. G-2S Type- III, Langol Housing Complex.
 - 5) Ch. Mology Maring (30) yrs, the then SO, TPL Div. S/O Ch. Mohon Maring of Kambang Khunou village, P.O & P.S. Tengnoupal, District Tengnoupal a/p QTR No. G-22 Type-III, Langol Housing Complex.

- 2. We have given our anxious consideration as to whether or not there was inadvertent error in listing the names of the accused in the investigation report and also our earlier order dated 09.03.2022. In careful perusal of the investigation report, it is clear that the charged accused persons are mentioned in para no. 6 (Charge against the accused persons) of Sub-Head "During Investigation" of the investigation report. In said para no. 6 (Charge against the accused persons) of the investigation report, the charge against whom are made consists of 7 (seven) accused namely:
 - "I) K. Premkumar Singh, the then SE-III, PWD, Manipur.
 - II) Oinam Inaoba Singh, the then EE, TPL Div., PWD, Manipur.
 - III) Soiminthang Singson, the then EE, TPL Div., PWD, Manipur.
 - IV) Veineillam Haokip, AE, TPL Div., PWD, Manipur.
 - V) Ch. Mology Maring SO, TPL Div., PWD, Manipur.
 - VI) Hemkhopao, 1st class contractor, of Chassad Avenue, Porompat, Imphal East District.
 - VII) Yumnam Ranjit Singh of Kakwa Khongnang Pheidekpi, Imphal West District."

- 3. On conjoint reading of the said letter of the Investigation Officer dated 11.03.2022 and the Investigation Report, it appears that there was inadvertent error in listing the names of the accused persons in the investigation report, in the first page i.e. para no. 5 of the Investigation Report. Para No. 5 of the investigation report should be read as:
 - "1) K. Premkumar Singh (59) yrs, the then SE-III, PWD, Manipur, S/O(L) K. Gulap Singh, of Chingakham Leikai, Moirangkhom, near Brajalal Institute of Sciences, Imphal West, PS Imphal.
 - 2) Oinam Inaoba Singh (61) yrs, the then EE, TPL Div. S/O (L) O. Mani of Khongman Zone-IV West, P.S Irilbung, Imphal East, the then EE.
 - 3) Shri Soiminthang Singson (60) yrs, EE, TPL Div. S/o late Nehkhopao Singson of Moreh Ward No. 9, Chikim Village, P.O. & P.S. Moreh, District Tengnoupal, District Tengnoupal a/p PWD Complex, Khuyathong, Imphal.
 - 4) Veineillam Haokip (39) yrs, AE, Sub-Div.II, Moreh, TPL Div. W/o Paojalal Haokip of Sugnum Munpi village, PO & PS Sugnu, Dist. Chandel a/p Qtr No. G-2S Type- III, Langol Housing Complex.
 - 5) Ch. Mology Maring (30) yrs, the then SO, TPL Div. S/O Ch. Mohon Maring Of Kambang Khunou village, P.O & P.S. Tengnoupal, District Tengnoupal a/p QTR No. G-22 Type-III, Langol Housing Complex.
 - 6) Hemkhopao (56) Yrs, 1st class contractor, S/o Paokhotong of K. Molnom village PO & PS Sugunu, Dist. Chandel a/p Chassad Avenue, P.O. & P.S. Porompat, Imphal East District.
 - 7) Yumnam Ranjit Singh (58) yrs. S/o Y. Gopal Singh of Moreh ward No. 8 a/p Kakwa Khongnang Pheidekpi, P.O. & P.S. Singjamei, Imphal West District."
- 4. This order is passed in continuation of our earlier order dated 09.03.2022.
