- [1] Perused the office note dated 10.03.2021 wherein and whereunder it is reported that Director (Inquiry), Manipur Lokayukta under his letter/application dated 06.03.2021 to the Lokayukta prays for constitution of a Technical Team consisting of 2 (two) Engineers for assisting the inquiry.
- [2] Register this application as Misc. Case.
- Perused the Misc. Case. In the earlier case similar with the [3] present complaint case, Lokayukta had passed an order dated 15.01.2021 in Misc. Case No. 1 of 2021 (Ref.: Complaint Case No. view that 2020) expressing our Committee/Technical Committee may be required to be constituted for assisting the Inquiry Officer to ascertain as to whether the work had been properly executed or not and also as to whether measurement of the work had been entered properly in the Measurement Book or not. We examined the present case, keeping the present case and the earlier complaint case wherein we had already passed order for constitution of the Expert Committee/technical Committee in juxtaposition, and are of the considered view that an order for constituting an Expert Committee/Technical Committee is also called for in the present case for proper and smooth processing of the Preliminary Inquiry. Lokayukta has already received list of Panel of expert submitted by (i) Chief Engineer (PWD), Manipur, (ii) Chief Engineer-cum-E.O., RED/MSRRDA and Under Secretary (RD&PR), Government of Manipur. After considering the list of Panel, mentioned above, we constituted a Technical Team consisting of (i) Mr. N. Khelemba, SW/ACE-II (from the PWD, Manipur) and (ii) Mr. Maibam Raju Singh, Executive Engineer of DRDA, Imphal West (from the RD&PR Department, Govt. of Manipur).
- [4] A Technical Team consisting of the same Engineers, mentioned in the above para, i.e. (i) Mr. N. Khelemba, SW/ACE-II (from the PWD, Manipur) and (ii) Mr. Maibam Raju Singh, Executive Engineer of DRDA, Imphal West (from the RD&PR

Department, Govt. of Manipur) is constituted to assist the Inquiry Officer of the present case. The Chief Engineer, PWD, Manipur and the Commissioner/Administrative Secretary (RD&PR), Government of Manipur are directed to make the service of the said Engineers available for assisting Inquiry Officer in the matters mentioned above as and when necessary. The date(s) of meeting with the Inquiry Officer will be intimated later on by the Director (Inquiry), Manipur Lokayukta.

- [5] Deputy Registrar, Manipur Lokayukta is directed to inform (i) the Director (Inquiry), Manipur Lokayukta; (ii) the Chief Engineer, PWD, Manipur; (iii) the Chief Engineer cum E.O., RED/MSRRDA; (iv) the Commissioner/Administrative Secretary (RD&PR), Government of Manipur; (v) Mr. N. Khelemba, SW/ACE-II (from the PWD, Manipur); (vi) Mr. Maibam Raju Singh, Executive Engineers of DRDA, Imphal West (from the RD&PR Department, Govt. of Manipur) for necessary action.
