Benjamin, S/o Shimthar of Ngari Raidulomai Village, Senapati (Complainant of Complaint Case No. 4 of 2020), (iii) Mr. Kh. Enoch of Lower Phibung Village Senapati (Complainant of Complaint Case No. 5 of 2020) and (iv) Mr. P.R. Amos, S/o Rozii of Kabung Khunou Village, Senapati (Complainant of Complaint Case No. 1 of 2021) as well as possible security arrangement for their safety from the side of the Home Department, Government of Manipur. The report/comment of the DGP, Manipur is highly required for passing appropriate order for the security arrangement of the complainants by the State Government.
