- 1. Perused the note dated 23.01.2021 of the Deputy Registrar, Manipur Lokayukta wherein it is stated that in a Writ Petition i.e. W.P. (C) No. 706 of 2020 before the High Court of Manipur between Shri Gangmei Gaidon Rongmei –Vs- The State of Manipur represented by the Commissioner (MAHUD), Government of Manipur and 3 Ors, Manipur Lokayukta represented by its Deputy Registrar has been made Proforma Respondent No. 4.
- 2. Register this matter as a Misc. Case.
- 3. On perusal of the writ petition i.e. W.P. (C) No. 706 of 2020, it is clear that the writ petitioner is not seeking any direct relief against the Proforma Respondent No. 4, but the relief sought for therein is for setting aside the impugned order being No. F.No. 5/28/2020-DIR (MAHUD) dated 12.11.2020 issued by the Director (MAHUD), Government of Manipur in consequence to the order of the Manipur Lokayukta dated 06.11.2020 passed in Complaint Case No. 1 of 2020 and Government of Manipur: Secretariat MAHUD Department letter No. MiscM-601/24/2020-MAHUD-MAHUD dated 12.11.2020. In the said writ petition, it is the case of the writ petitioner that the Government of Manipur, Department of MAHUD while passing the impugned order dated 12.11.2020 had misunderstood and misinterpreted the order of the Manipur Lokayukta dated 06.11.2020 passed in Complaint Case No. 1 of 2020.
- 4. Even if the direct relief is not sought for in the said writ petition against the Manipur Lokayukta (Proforma Respondent No. 4), the Proforma Respondent No. 4 is required to be represented by a Senior Government Advocate so as to assist the High Court in discussing the order of the Manipur Lokayukta dated 06.11.2020 passed in Complaint Case No. 1 of 2020 for deciding the core issue i.e. whether the Director (MAHUD), Government of Manipur while passing the impugned order dated 12.11.2020 has misunderstood or misread the order of the Manipur Lokayukta dated 06.11.2020.
- 5. Accordingly, learned Additional Advocate General, Government of Manipur, namely **Shri Rarry Mangsatabam** is authorised to represent the Proforma Respondent No. 4 (Manipur Lokayukta) of the Writ Petition (Civil) No. 706 of 2020 before the High Court of Manipur in all the proceedings of the said writ petition.
- 6. Deputy Registrar, Manipur Lokayukta is to send the authorisation letter of the learned Additional Advocate General, Government of Manipur, namely Shri Rarry Mangsatabam, today itself.
