## MISC. CASE NO. 1 OF 2021

- 1. Register this application as separate misc. case.
- 2. Investigating officer under her application dated 25.09.2021 prays for extension of the period for completion of investigation by another 6 months. The said application dated 25.09.2021 of the investigating officer was forwarded by the Director (Inquiry) under his letter dated 25.09.2021 to the Hon'ble Chairperson, Manipur Lokayukta. In said letter, the investigation officer mentioned that the examination of persons acquainted with the facts circumstances of the case including all 18 (eighteen) Councillors of Thoubal Municipal Council, 34 (thirty four) Ward Members, staff of officers of TMC were delayed due to the COVID-19 pandemic and the restriction/curfews imposed by the State of Government. For convenience, the relevant portion of the said application of the investigating officer dated 25.09.2021 is reproduced here as under:-

"That, the collector of new documents from concerned authorities and further correspondences took a considerable amount of time as new relevant documents came into light during the course of investigation. The examinations of persons acquainted with the facts and circumstances of the case including all 18 (eighteen) Councillors of Thoubal Municipal Council, 34 (thirty four) Ward Members, staffs and officers of TMC and tender bidders from the states of Assam and West Bengal for the said supply which is in question in this FIR were considerably affected and delayed due to the COVID 19 pandemic and the restrictions life curfews imposed by the state government vide the following Government orders:-

That during the pendency of the investigation of the case, I was engaged as the Presenting Officer of 2 (two) Departmental Enquiry cases initiated against officers of the rank of Inspector of Manipur Police vide DGP Manipur Order No. E/43/4/2020- PHQ(Adm)/388 dated 12/01/2021."

- 3. On considering the chaotic atmosphere in the society because of covid-19 pandemic and also the other circumstances leading to the difficulties of conducting smooth investigation, we are of the considered view that the period for completing the investigation is required to be extended by another 6 months w.e.f. 27.09.2021. Accordingly, a further 6 month period is granted for completion of the investigation. The investigating officer should complete the investigation without further delay.
