

**COMPLAINT CASE NO. 1 OF 2021**

**06.05.2022**

1. Mr. N. Alex Meitei, Advocate, junior to Mr. Ajoy Pebam appears on behalf of Respondent Nos. 1 (Shri M.L. Markson), 2 (Shri A. Kapani), 3 (Shri K. Holison Raomei), 4 (Shri Rangnamei Rang Peter, IAS), 7 (Shri A. Theiba), 8 (Shri Mutum Shyamsunder Singh), 9 (Shri L.N. Veinii), 10 (Shri R.R. Khullu), 11 (Shri L.P. Dahrii), 12 (Shri L.L. Paopeii), 13 (Smt. E. Arila), 14 (Shri Luihing), 15 (Smt. S.W. Wortimshok), 16 (Smt. Alfina Rongkamei Dowang), 17 (Shri L.L. Dani) and 18 (Shri R.Y. Joel) prays for at least 10 days' time for filing comment to the Preliminary Inquiry Report. The prayer is allowed subject to the payment of Rs. 4000/- (Rupees four thousand) only as cost which shall be paid to the complainant on or before the next date. It is made clear that until and unless the awarded cost is paid to the complainant, the comment from the side of the Respondent Nos. 1, 2, 3, 4, 7, 8, 9, 10, 11, 12, 13, 14, 15, 16, 17 and 18 will not be accepted. Complainant also appears in person.
2. Mr. Ch. Genius Singh, learned counsel appearing for the Respondent No. 5 (Shri Stiff Khapudang MCS) files comment to the Preliminary Inquiry Report on behalf of the Respondent No. 5. Mr. Paulianmung Tonsing, learned counsel appearing on behalf of Respondent No. 6 (Smt. Regina Hongray, MCS) also files comment on behalf of Respondent No. 6.
3. Learned counsels appearing for the Respondent Nos. 5 and 6 are directed to furnish a copy of the comment filed by them to the complainant.

In compliance of our order dated 25.04.2022 passed in the present case, Officer-in-Charge, Senapati Police Station under his letter being Memo No. 20/SPT-PS/2022/269 dated 30.04.2022 has forwarded a letter of the Investigation Officer, Senapati Police Station dated Nil, wherein it is stated that the Death Certificate in respect of Respondent No. 17, Mr. L.L. Dani, S/o Luni of Vakho issued by the Registrar (Birth & Death), PHC-Maram dated 28.10.2021 is found to be true and genuine.
5. As observed in the above para, the name of Respondent No. 17 i.e. Mr. L.L. Dani, S/o Luni of Vakho is hereby deleted from being a Respondent in the present case.
6. List this case on 18.05.2022 for filing of comment and further proceeding.
