

COMPLAINT CASE NO. 6 OF 2021

1. Complainant appears in person. Mr. Wangpam Yangya, junior Advocate to Mr. RS Reisang, Senior Advocate entered appearance on behalf of Respondent Nos. 1, 2, 4, 5, 6, 7, 8, 9, and 10; Mr. L. Rojishon Singh, Advocate entered appearance on behalf of Respondent Nos. 12 and 13; and Mr. Ch. Genius, Advocate entered appearance on behalf of respondent no. 11.

2. Mr. Wangpam Yangya, learned counsel appearing for the Respondent Nos. 1, 2, 4, 5, 6, 7, 8, 9, and 10 files comments to the Preliminary Inquiry Report on behalf of Respondent Nos. 1, 2, 4, 5, 6, 7, 8, 9, and 10 by furnishing a copy of it to the complaint in the court itself. He is directed to furnish a copy of the said comment to the learned counsels appearing for the other Respondents within 2 (two) days.

3. In compliance of order dated 24.08.2022 passed in the present complaint case, Director (Inquiry), Manipur Lokayukta vide letter dated 8.09.2022 submitted a report that the date of the death of Respondent No. 3 (Shri SP. Mashungam) has been verified by the officer in-charge of Shangsak Police Station, Ukhrul District. The said verification report of officer in-charge of Shangsak Police Station, Ukhrul District had been forwarded by Superintendent of Police, Ukhrul District to the Directory (Inquiry), Manipur Lokayukta vide letter dated 07.09.2022. As per the verification report submitted by the officer in-charge of Shangsak Police Station, Ukhrul District supported by a Death Certificate issued by Headman, Ramva Village, Ukhrul District, Manipur and also by Death Certificate issued by the Registrar, Registration of Births & Death, District Hospital, Ukhrul, Manipur, Respondent No. 3 (Shri SP. Mashungam) had expired/died on 22.02.2020.

3.1 This being the situation, the name of the Respondent No. 3 (Shri SP. Mashungam) is deleted from being one of the Respondents in the present case.

4. As prayed for by the learned counsel appearing for Respondent No. 11 and also by the learned counsel appearing for Respondent Nos. 12 and 13, 10 days' time, as last chance, is granted for filing to Respondent Nos. 11, 12 and 13 for filling their comments to the Preliminary Inquiry Report.

5. List this case on 07.10.2022 for filing of comments on behalf of Respondent Nos. 11, 12 and 13 and also for further proceeding.
