- 1. Register this application as separate misc. case.
- 2. Director (Inquiry), Manipur Lokayukta vide his letter being no. 1/ML/DIR(INQ)/2022/738 dated 03.03.2023 of the Manipur Lokayukta requested for constitution of a technical member for assisting the Investigating Officer, Shri Manoj Prabhakar M, IPS of FIR No. 1(02)2023 CB-PS u/s 13PC Act, 120-B/34 IPS & 5 Manipur Public Service Personal Liability Act, 2006 in assessing the technical parameters of the construction/development of pubic assessment. In his letter, it is also mentioned that the technical committee having the expertise in technical material would be required for physical verification of the work under investigation.
- 3. Manipur Lokayukta vide order dated 04.04.2022 passed in Misc. Case No. 7 of 2022 (Reference : Complaint Case No. 3 of 2020) had already constituted a technical team comprising of :
  - (i) Mr. Telheiba Konsam, EE (PWD/Chandel), Manipur (from PWD, Manipur) and
  - (ii) Mr. T. Shivdutta Singh, EE (PIU-III) Tamenglong, RED/MSRRDA (from Rural Engineering Department, Manipur State Rural Roads Development Agency).

As the nature of the Complaint Case No. 3 of 2020 is *peri materia* with the present complaint case i.e. Complaint Case No. 3 of 2021, considering the earlier order of the Manipur Lokayukta dated 04.04.2022 passed in Misc. Case No. 7 of 2022 (Reference: Complaint Case No. 3 of 2020) and nature of the complaint in the present case i.e. Complaint Case No. 3 of 2021, we are of the considered view that the technical committee constituted vide our order dated 04.04.2022 passed in Misc. Case No. 7 of 2022 (Reference: Complaint Case No. 3 of 2020) will also be the technical committee of the present case i.e. FIR No. 1(02)2023 CB-PS u/s 13PC Act, 120-B/34 IPS & 5 Manipur Public Service Personal Liability Act, 2006 arising out of Complaint Case No. 3 of 2021.

4. Accordingly, Deputy Registrar, Manipur Lokayukta is directed to inform the said two Members of Technical Team i.e. Mr. Telheiba Konsam, EE (PWD/Chandel), Manipur and Mr. T. Shivdutta Singh, EE (PIU-III) Tamenglong, RED/MSRRDA by mentioning their new

place of posting. Deputy Registrar is further directed to inform the said two Members of the Technical Team that their services have been utilised by Manipur Lokayukta by invoking its power under Section 28 of the Manipur Lokayukta Act, 2014. Failing to comply with our order will have legal consequences.
