

**COMPLAINT CASE NO. 6 OF 2021**

1. None appears for the Complainant.
2. Mr. Wungpam Yangya, learned counsel appears on behalf of respondent nos. 1, 2, 4, 5, 6, 7, 8, 9 and 10; Mr. M. Dijendra, learned counsel appears on behalf of respondent no. 11 and Mr. Ajoy Pebam, learned counsel appears on behalf of respondent nos. 12 and 13.
3. Heard the learned counsels appearing for the Respondents. It is clear from the record that we need certain clarification regarding the point mentioned in para no. 4 of our order dated 19.12.2023. Since we are not satisfied with the comment/clarification from the Tribal Affairs and Hills Department, Government of Manipur, we had passed an order dated 03.02.2023 in the present complaint case, wherein we made observation in para no. 6 that we need clarification from the Ministry of Finance, (Finance Commission Division), Government of India. Accordingly, we had directed Deputy Registrar, Manipur Lokayukta to seek comment/clarification regarding the point mentioned in para no. 4 of our order dated 19.12.2022 from the Ministry of Finance, Department of Expenditure, Finance Commission Division, Block No. 1, 5<sup>th</sup> Floor, CGO Complex, New Delhi – 03.
4. In compliance of our order dated 03.02.2023, Deputy Registrar, Manipur Lokayukta has written a letter to the Director (FCD), Ministry of Finance, Department of Expenditure, Finance Commission Division, Block No. 1, 5<sup>th</sup> Floor, CGO Complex, New Delhi – 110003 on 06.02.2023 to furnish clarification mentioned in para no. 4 of our order dated 19.12.2022 within a fortnight of the receipt of the letter. Track consignment record of the Speed Post Consignment No. EE435384837IN shows that the said letter of the Deputy Registrar, Manipur Lokayukta has been received by the office of the Director (FCD), Ministry of Finance, Department of Expenditure, Finance Commission Division, New Delhi on 09.02.2023. But, as on today, we have not yet received any letter/reply from the Director (FCD), Ministry of Finance, Department of Expenditure, Finance Commission Division, New Delhi. For a just and fair decision of the case and also in public interest, we direct Deputy Registrar, Manipur Lokayukta to send a Reminder to the Director (FCD), Ministry of Finance, Department of Expenditure, Finance Commission Division, New Delhi forthwith with a request to furnish the above mentioned clarificati on within one week from the date of receipt of the Reminder.
5. List this case for further proceeding after 2 (two) weeks' time i.e. on 13.03.2023.
