- 1. None appears for complainants. Mr. P. Ibomcha learned counsel appeared for respondent No. 6 in Complainant Case No. 1 of 2021; Respondent No. 7 in Complaint Case No. 4 of 2020 and Respondent No. 6 in Complaint Case No. 5 of 2020; and Mr. L. Rojeshon learned counsel appeared on behalf of Respondent No. 1, 2, 3, 4, 7, 8, 9, 10, 11, 12, 13, 14, 15, 16 and 18 in Complaint Case No. 1 of 2021; Respondent No. 1, 2, 3, 4, 5, 8, 9, 10, 11, 12, 13, 14, 15, 16, 17, 18, 19, 20, 21, 22, 23, 24, 25, 26, 27, 28, 29 & 30 in Complaint Case No. 4 of 2020 and Respondent No. 1, 2, 3, 4, 7, 8, 9, 10, 11, 12, 13, 14, 15 & 16 in Complaint Case No. 5 of 2020 are present.
- 2. By our earlier order dated 3.05.2023 the administrative Secretary (TA& Hills), Government of Manipur was directed to produce the file being No. 22/202/2018-(HILLS) mentioned in the office memorandum dated 09.11.2018 issued under the signature of Shri Letkhogin Haokip, Addl. Chief Secretary (TA& Hills) Government of Manipur, now retired. Further, It was left to the Administrative Secretary (TA& Hills) Government of Manipur to take his own decision if he want to appear before the Manipur Lokayukta, so that he may appraise the Manipur Lokayukta about facts and circumstances leading to the issuing of the said office memorandum dated 09.11.2018 signed by Shri Letkhogin Haokip, Addl. Chief Secretary (TA& Hills), Government of Manipur, now retired.
- 3. Copy of our earlier order dated 03.05.2023 was served to the Department of (TA & Hills), Government of Manipur only on 11.05.2023. In the present law and order situation in the state of

Manipur we are of the considered view that some more time i.e about 2 weeks' time is granted to the Department of (TA & Hills), Government of Manipur to produce the aforesaid file for perusal. Further, it is left to the Administrative Secretary (TA& Hills) Government of Manipur to take his own decision if he wants to appear before the Lokayukta regarding this matter. It is also made clear that if necessary, we may take recourse to the necessary consequences prescribed by law if the Administrative Secretary (TA& Hills), Government of Manipur fails to comply the directions made by us in our order dated 03.05.2023 and also this order.

- 4. Deputy Registrar is directed to communicate this order to the Addl. Chief Secretary (TA& Hills), Government of Manipur for necessary action without fail and also to all the parties of complaint cases.
