

COMPLAINT CASE NO. 4 OF 2021

1. Perused the office note dated 27.06.2023 and also the letter of the Director (Inquiry), Manipur Lokayukta dated 26.06.2023 to the Manipur Lokayukta stating that Ms. Diana Kongjengbam, MPS, Addl. Supdt. Of Police, who is the Investigating Officer of FIR No. 10(12)2022 (Crime Branch Police Station) in connection with Complaint Case No. 4 of 2021 of Crime Branch Police Station has been detached from CID (CB), Manipur and attached with PHQ, Imphal as Staff Officer to DGP, Manipur vide PHQ Order No. E/.37/13(1)2015-PHQ(Adm)/6170 dated 14.06.2023.

2. Under the same letter dated 26.06.2023, the Director (Inquiry), Manipur Lokayukta also suggested the name of Shri T. Bimolchand Singh, Dy. Sp. Of CID (CB) for utilisation of his service as Investigating Officer of FIR No. 10(12)2022 (Crime Branch Police Station).

3. We have considered the said letter of the Director (Inquiry), Manipur Lokayukta dated 26.06.2023 and after such consideration, we by invoking our jurisdiction under Section 28 of the Manipur Lokayukta Act, 2014, hereby utilise the service of Shri T. Bimolchand Singh, Dy. Sp. Of CID (CB) as Investigating Officer of FIR No. 10(12)2022 (Crime Branch Police Station). Shri T. Bimolchand Singh, Dy. Sp. Of CID (CB) has to take over the file of FIR No. 10(12)2022 (Crime Branch Police Station) immediately from Ms. Diana Konjengbam, MPS, the then Investigating Officer of FIR No. 10(12)2022 (Crime Branch Police Station) and complete the investigation of the case as early as possible. The Investigating Officer, Shri T. Bimolchand Singh, Dy. Sp. Of CID (CB) while conducting the investigation will not be under the supervision of his

senior officer of his department or the station where the present case is registered. It is also made clear that the Investigating Officer shall conduct the investigation with full co-ordination with the Director (Inquiry), Manipur Lokayukta. Entrusting the investigation of the present case to Shri T. Bimolchand Singh, Dy. Sp. Of CID (CB) will be in addition to his normal duty wherever he is posted without disturbing his posting and as such entrustment of the present case for investigation will not amount to new transfer and posting. It is for the purpose of maintaining the sanctity of Manipur Lokayukta and for not interfering with the proceeding of the case before the Manipur Lokayukta and inquiry and investigation are parts of the proceeding of the case filed before Manipur Lokayukta.

4. As prayed for, the time period for completion of the investigation is further extended for a period of 5 months w.e.f. 29.06.2023.

5. Registry is directed to furnish a copy of this order to Director (Inquiry), Manipur Lokayukta; Shri T. Bimolchand Singh, Dy. Sp. of CID (CB) and Ms. Diana Kongjengbam, MPS, Staff Officer to DGP, Manipur for necessary action and compliance.
